ORDER

Subject: Issuance of DSIR Registration Certificate in respect of Public Funded Research Institutes registered by DSIR with Revised Validity up to 30.09.2024 –reg.

DSIR is issuing certificate of Registration to Public Funded Research Institutes other than Hospital up to 31.03.2024 as per MoF Notification No. 334/03/2023- TRU dt 01.02.2023 wherein standalone Customs exemption notifications was extended up to 31.03.2024 for the purpose of undertaking review during the year.

2. Reference is now invited to the Gazette Notification No. 07/2024- Customs dt 29.01.2024, regarding extension of the validity of exemptions lapsing on 31.03.2024 up to 30.09.2024 (copy Enclosed) wherein Notification No. 51/96-Customs, dated the 23rd July, 1996, published vide number G.S.R. 303(E), dated the 23rd July, 1996 is being extended beyond 31.03.2024 up to 30.09.2024.
3. In view of the above, it has been decided to extend the validity of registration up to 30.09.2024 for all existing registered Public Funded Research Institutes having valid registration during the period and who's Registration Certificate is lapsing on 31.03.2024.
4. However, Renewal of Registration of PFRIs shall be processed by the department as per the existing guidelines and procedures duly laid down in DSIR.
