**Sub: Renewal of Registration of Public Funded Research Institutions, Universities, IITs, IISc., Bangalore; Regional Engineering Colleges (other than a hospital) beyond 31.08.2025**

Madam/Sir,

As per our records, Registration of your organization as PFRI is valid up to **31<sup>st</sup> August 2025**. In accordance with the terms and conditions of the registration as a Public Funded Research Institution by DSIR, Ministry of Science & Technology mentioned in the registration certificate last issued to your organization/ institution, the application for renewal of registration is required to be submitted three months prior to the expiry of the validity of registration. DSIR has initiated the process for renewal of registration of the registered PFRI beyond 31<sup>st</sup> August 2025; therefore, an online application for renewal of registration may be submitted at the SERVICE PLUS portal at the given link <https://serviceonline.gov.in/dbt>. Instructions for filing the online application for Renewal of Registration of PFRI can be accessed from the DSIR website: [dsir.gov.in](http://dsir.gov.in).

**Further**, Institutions/ Universities who had **valid PFRI registration up to 31.08.2023 & 31.08.2024** can also apply for renewal of Registration before 31.08.2025, with a **delay statement**, failing which their renewal application will not be considered by the Department as per DSIR Guidelines for PFRI registration and the institutions/ universities for which the registration lapses will need to apply for fresh registration.

2. Please note that the **Hard Copy of the application need not be submitted** for applying for Renewal of PFRI registration
