This is in reference to the **Call letter dated 19.11.2024** for renewal of recognition of In-house R&D centers beyond **31/03/2025** (enclosed).


2. As per our records, recognition/renewal of In-house R&D recognition granted to your In-house R&D unit was valid up to **31st March 2025**. In accordance with the terms and conditions of the recognition, application for renewal of recognition is required to be submitted three months prior to the expiry of the validity of recognition. In this regard, majority of the companies have submitted their application on email ids as per **Call letter dated 19.11.2024** and the same have either been processed or are under process in DSIR. There is **no need to re-submit the applications to DSIR**, in case it has been **already submitted** on email ids listed in Call letter dated 19.11.2024.

NB. It may be noted that the procedure for receipt and processing of applications remains same as per Call letter dated 19.11.2024 **except** a change in email id henceforth for streamlining of process of receipt of applications on a dedicated email id rdi-renewal@gov.in

3. In respect of the companies where application regarding renewal of In-house R&D recognition beyond **31/03/2025** granted to your In-house R&D unit **has not been submitted to the department** till date, the companies are requested to submit one set of **signed pdf application (not exceeding 20MB file size)** immediately and latest by **15th July, 2025** on email id rdi-renewal@gov.in as DSIR is about to close the process for renewal of recognition of R&D centers beyond **31/03/2025**.

NB. Please note that email id rdi-renewal@gov.in is only for receipt of applications and reverse communication (if any) shall not be made through this email id. 2. Please note that **No Hard Copy of the application needs to be submitted**. Company is required to submit a covering letter with filled Checklist (Annexure-I) and desired Annexures and documents as mentioned in the Checklist in the form of **single PDF scan document (Scanned document not exceeding 20MB file size)**. In case of scanned file size exceeding 20MB limit, files may be compressed accordingly. Please note that the company may combine multiple scanned files into **single pdf file** (of upto 20MB size only) in the email being sent to DSIR with the subject of email clearly indicating request for **"Renewal of Recognition beyond 31.03.2025 submitted by Name and Recognition number of the company"**.

3. In case, the Company has more than one recognized R&D unit under the same recognition letter/number, **Separate Part B of the application is to be submitted for each unit**. Also, in respect of video of R&D unit, the same may please be pasted as link in the body of the email.

4. The Companies seeking recognition of **"New additional R&D centre"** may provide details of such R&D centre along with details of R&D centres due for Renewal beyond 31.03.2025. However, in such case it may be ascertained that the company must send separate application to DSIR in PDF, scan and signed by the Managing Director/ Member of Board of Director of the Company along with all enclosures with **"Separate Covering Letter"** attached in email with subject clearly indicating request for **"Renewal of Recognition"** and other email with subject clearly indicating request for **"Recognition of New Additional R&D centre"**.
